## Record-After-the-Fact

### THE DIFFERENCE BETWEEN RATF & PRE-EVENT RECORDING

The practice of continuous background recording is common among body-worn camera suppliers that provide pre-event recording, a practice that adds up to two minutes of video footage before an initiated recording to every captured event. Pre-event recording, however, provides no fail-safe for incidents for which a recording was never initiated.

RATF doesn't require a recording to be initiated and extends the ability to reach further back in time for evidence, even days after the incident. Additionally, RATF doesn't add two minutes of overhead to each recorded event submitted as evidence. RATF events are individually created within a specified window of time and only by authorized users.

## Psychological Factors To Keep In Mind While Investigating

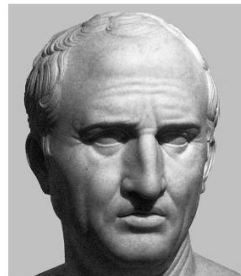
**Confirmation Bias:** The unwitting tendency to seek out evidence that supports a pre-conceived belief, and minimize or downplay evidence inconsistent with that belief.

**Cognitive Dissonance:** Individuals experience discomfort or tension due to contradictory beliefs or attitudes. When confronted with new information that challenges their existing beliefs, people may instinctively reject the new information to reduce psychological discomfort.

**Overconfidence Bias:** Individuals believing that their knowledge or beliefs are superior to new information presented to them. This bias can lead people to dismiss new information as incorrect or misguided without fully considering its validity.

**Belief Persistence:** Even when presented with evidence that contradicts their beliefs, individuals may continue to hold onto their existing beliefs despite being presented with contradictory evidence, often because their beliefs are deeply ingrained or emotionally charged.

**Focusing Effect:** The tendency to place too much importance on one aspect of an incident or event. There are typically multiple contributing factors, which are often dependent on each other, and investigators need to uncover and consider all possible factors.

## Psychological Factors To Keep In Mind While Investigating

**The Time Factor** – Memory fades. The longer the delay between witnessing an event and recalling it, the more a person forgets, especially the finer details of the event.

**Post-Event Information** - A witness may have learned new information since first observing or describing an incident, which during later testimony is believed to be and is presented as knowledge he or she had at the time of the incident.

**Recall (Reporting) Bias** - A bias which occurs when the way a witness answers a question is affected not just by the what actually occurred, but also by the witness's prior memories, which can get associated with the recent incident.

**Perception Factor** - The witness viewed the incident in poor light, at night, against back lighting, from a great distance, in the fog, or very briefly, and thus had limited or impaired perception.

**Attention Factor** - Distractors that draw attention away from the incident, doing something else at the time, many people being present, or distractive noise, causes information to be missed.

**Unfamiliarity Factor** - Unexpected events or unfamiliar circumstances limit the mind's ability to absorb all of the information associated with the event. Expected events or familiar circumstances are already in our memory, and require less bandwidth to absorb the new information.

## Validity of Evidence

Evidence needs to be examined for validity before using it for investigative and analysis purposes. Here are the three steps I use for verifying the validity before relying on evidence:

**Validity** (*Being well-grounded, sound, or correct.*)

1. **Authenticity:** (*Being genuine, real, or what is claimed.*) - Evidence must first be verified to be in its original form, or proven to be an unmodified copy, redactions notwithstanding. If something is fabricated, forged, photoshopped, or otherwise modified, it should not be considered valid. Also, consider the source!
2. **Veracity:** (*Being accurate, factual, or truthful.*) – Evidence must be examined for accuracy. If the evidence conflicts with itself, or is contradicted by other evidence, that needs to be taken into consideration when utilizing that evidence for investigative purposes.
3. **Consistency:** (*Being in agreement or harmony with itself and other valid evidence.*) – Evidence must be consistent within itself and be in agreement with other valid evidence. It must align with the overall sequence of events. Otherwise, it has to be considered inaccurate for investigative purposes and utilized only with those inconsistencies in mind.

## Quality of Evidence

All evidence is not created equal, it has varying levels of relative quality. This is how I generally rate the quality of evidence used in my investigative and analysis efforts:

**Quality** (Degree of confidence in accuracy.)

**Hard Evidence:** Valid evidence that has been recorded and cannot easily be refuted, just interpreted. Examples include film footage, photographs, recorded conversations, or radio communications.

**Firm Evidence:** Valid evidence that has been documented, such as official government reports, interview testimony, transcribed or otherwise recorded, documents and records, emails, and text messages, that has been corroborated by other types or sources of evidence.

**Soft Evidence:** Valid evidence that has not been corroborated by other evidence or by separate sources.
