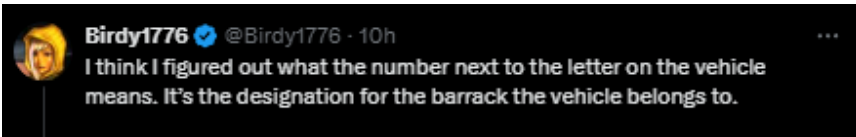

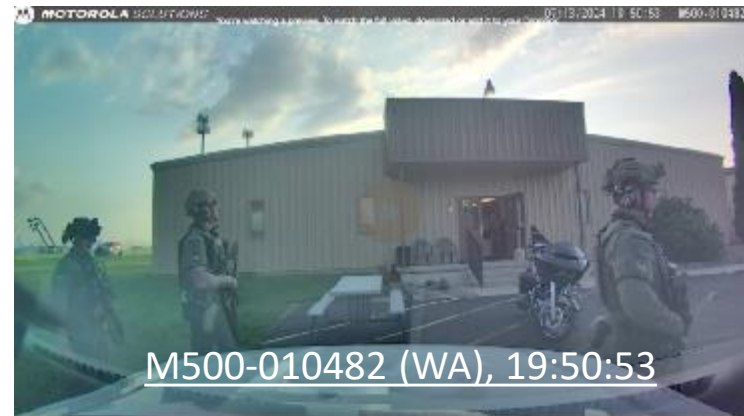

At 18:27:05, after arranging for CAT #1 to take the Terradyne to the hospital to support a request for tactical resources to set up a perimeter, Sgt. Lenz states that he requested North Hills SRT to backfill those resources. We can see in dashcam video that they do arrive, along with members of the City of McKeesport SWAT. It is not known if they brought their Allegheny County armor, but it would be safe to assume they did. They likely parked it on the rally side, perhaps near the BuC Command Center or along the AGR fence.

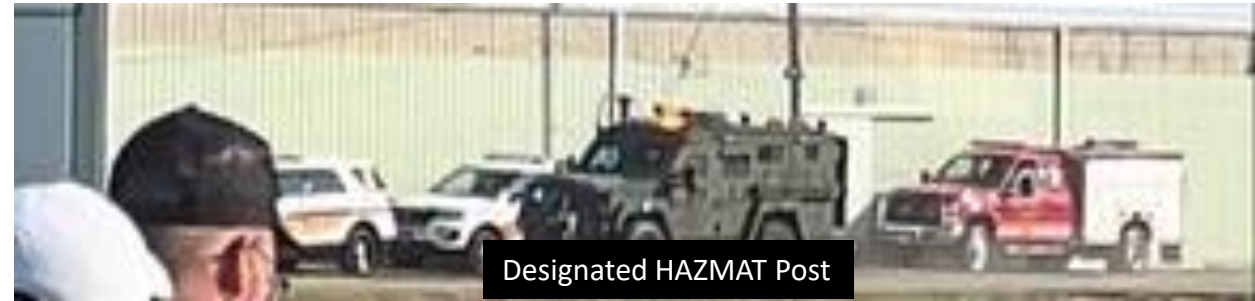

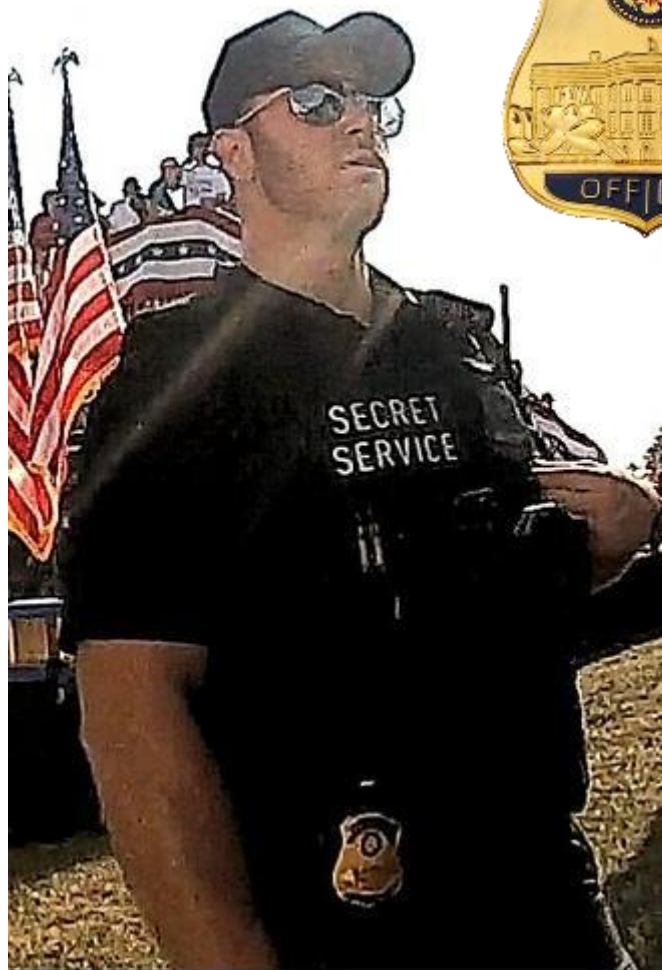

To accomplish their mission, CAT personnel conduct thorough tactical advance planning and extensive coordination with supporting tactical entities.
