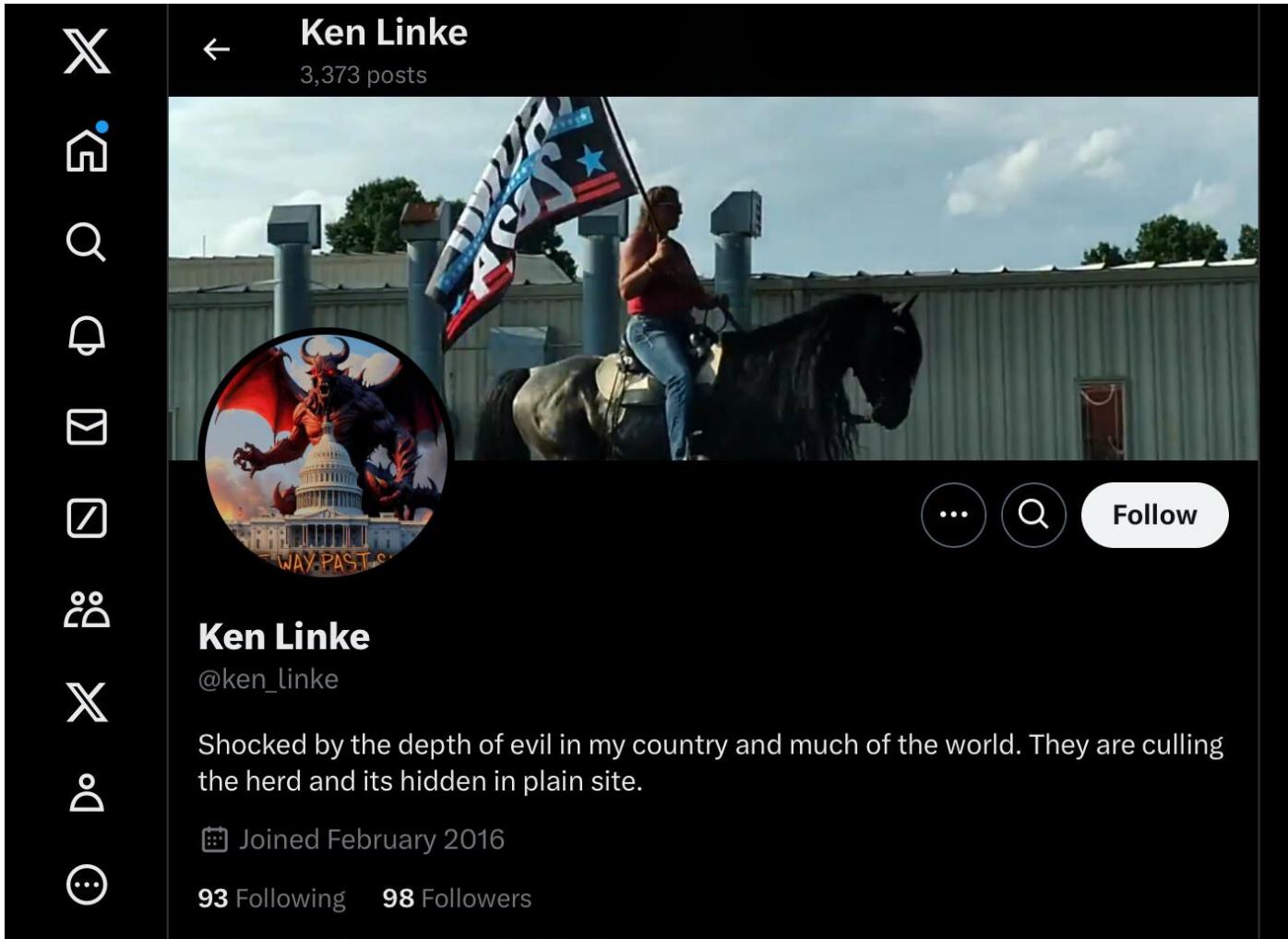

Since you were so kind as to check my work, I thought I would return the favor.

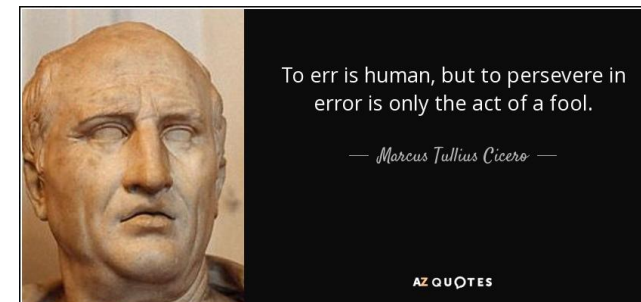
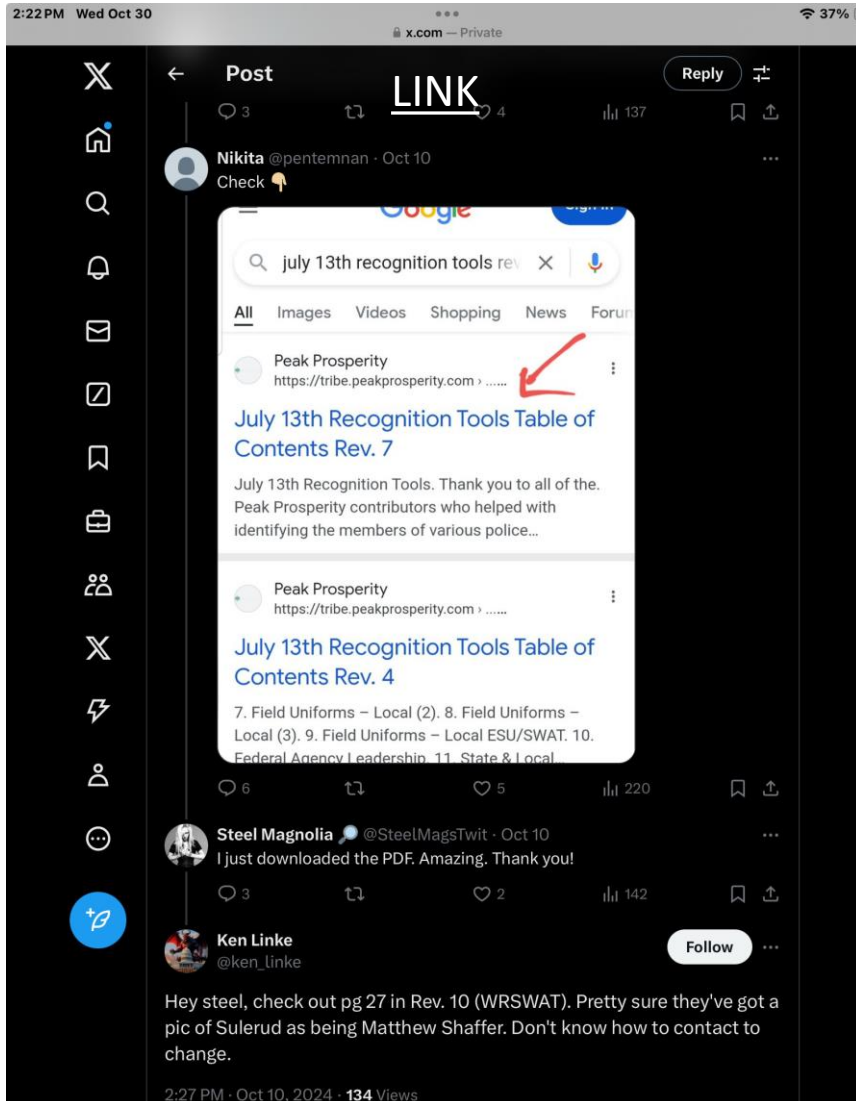

1. Adams Township had to raise funds to get K9 Kiko, and all the equipment needed to support a K9 unit. [LINK](#)
