| | attempted assassination. |

| | schedule and upcoming appearances in Pennsylvania. |

| | Trump and President Biden, including events scheduled to take place in Western Pennsylvania. |

| [00:09:52.600> 00:10:04.600] | On July 6, the subject registered to attend the rally, and that same day, he specifically searched for |

| [00:10:05.600> 00:10:14.600] | Where will Trump speak from at Butler Farm Show, quote, Butler Farm Show podium, and quote, Butler Farm Show photos? |
| [00:10:14.600> 00:10:20.600] | On July 8, the subject searched, quote, "AGR International." |
| [00:10:20.600> 00:10:30.600] | On July 9, he searched, quote, "holistic calculator," and on July 10, he searched, quote, "weather and butler." |
| [00:10:31.600> 00:10:40.600] | In the 30 days prior to the attack, the subject conducted more than 60 searches related to President Biden and |
| | former President Trump. |
| [00:10:40.600> 00:10:51.600] | A particular note, our investigation identified specific searches conducted on July 5 to include, quote, |
| | "when is the DNC convention?" |
| [00:10:52.600> 00:11:05.600] | When is the RNC in 2024? Next, regarding the two improvised explosive devices located in the shooter's |
| | vehicle, as well as the device found in his bedroom, |
| [00:11:05.600> 00:11:15.600] | the subject conducted multiple searches pertaining to explosive devices as early as September 2019 |
| | continuing through this summer. |
| [00:11:16.600> 00:11:31.600] | These searches specifically included, quote, "debtonating cord," quote, "blasting cap," quote, |
| | "how to make a bomb from fertilizer," and quote, "how to remote detonators work." |

| [00:11:31.600> 00:11:42.600] | The subject also searched for ammonium nitrate, nitromethane, and other materials consistent with the manufacturing of explosive devices. |

| | that components used by the subject were legal to purchase and readily available online. |

| | concluding it was and remains fully operational. |

| | accounts were encrypted. |

| | internet-based email service. |

| | grounds, as well as the AGR complex to the property owners in a timely fashion. |

| | of each location, exhausting all efforts to collect any items of evidentiary value. |

| | the final release of the scene seven days after the attack. |

| | and policies for the return of crime scenes to the property owner. |

| [00:13:58.600> 00:14:05.600] | I would now like to clarify the process undertaken to release the subject's body to his family. |
| [00:14:05.600> 00:14:16.600] | After rendering the scene safe and following our established evidence gathering procedures, the FBI contacted the Butler County coroner's office. |
| [00:14:17.600> 00:14:23.600] | Subsequently, the coroner removed the body from the scene and conducted a death investigation. |
| [00:14:23.600> 00:14:31.600] | The Butler County coroner's office then deferred to have the Allegheny County Office of the |
| | Medical Examiner conduct the autopsy. |
| [00:14:31.600> 00:14:44.600] | Once Allegheny County completed the autopsy, the Butler County coroner's office consulted with |
| | the FBI asking if there were any additional necessary investigative steps with respect to the body. |

| | to release the remains to the subject's family. |

| | to request at the coroner or medical examiner maintain indefinite custody of a deceased subject's body |

| [00:15:28.600> 00:15:42.600] | The autopsy report indicated the subject was pronounced deceased at 6.25 p.m. on July 13, 2024 as a result of a single gunshot wound to the head. |
| [00:15:43.600> 00:15:52.600] | All of our review evidence collected from the AGR roof and from the subject's body are consistent with the round fired by the secret service site. |
| [00:15:52.600> 00:16:01.600] | Additionally, the toxicology report revealed negative results, quote, for alcohol and drugs of abuse. |
| [00:16:01.600> 00:16:10.600] | Next, regarding questions surrounding the release of first responders from the shooting scene on the night of July 13. |

| [00:16:17.600> 00:16:26.600] | As the law enforcement community assembled in Butler was actively responding to public safety risks |
| | and assisting with investigative activity throughout the night. |

| | continues to this day. |
| [00:16:38.600> 00:16:47.600] | Our priorities that night as shared by local law enforcement were to secure the scene, preserve |

| [00:16:47.600> 00:16:56.600] | As previously reported, the FBI and the Pennsylvania State Police conducted a standard victim interview of former President Trump. |
| [00:16:56.600> 00:17:07.600] | During this productive interview, agents took the time to provide the former president with an in-depth |
| | briefing on the investigation and answered his questions regarding the attempt on the investigation. |
| [00:17:07.600> 00:17:13.600] | Regarding the attempt on his life, we're grateful to the former president for his cooperation and his time. |
| [00:17:13.600> 00:17:21.600] | I will now provide an update to the timeline associated with the subject's actions prior to the shooting. |
| [00:17:21.600> 00:17:30.600] | Prior witness interviews indicated the subject was in the area of the AGR building complex at 426 PM. |
| [00:17:31.600> 00:17:47.600] | Subsequent digital evidence review shows the subject was in fact near the farm show airstrip, walking past a row of vendors outside the secure perimeter approximately a half mile away from the AGR grounds at 426 PM. |
| [00:17:47.600> 00:17:58.600] | Second video obtained from a local business showed the subject climb to the roof of the AGR complex at approximately 605 PM. |
| [00:17:59.600> 00:18:13.600] | Video from a local business, police dash cam and police body cameras confirmed the subject's movement across multiple AGR building roofs between 605 and 608 PM. |
| [00:18:13.600> 00:18:20.600] | Finally, at 611, the subject fired eight rounds before being neutralized. |
| [00:18:21.600> 00:18:32.600] | Our overall finding is the subject was only on the roof for approximately six minutes prior to the shooting between 605 and 611 PM. |
| [00:18:32.600> 00:18:38.600] | The FBI continues to work diligently to determine the subject's motive. |
| [00:18:39.600> 00:18:50.600] | We believe the subject engaged in detailed attack planning well in advance of the campaign rally. |

| | We continue to pursue all investigative leads to determine any possible links to co-conspirators. |

| [00:19:01.600> 00:19:20.600] | So this is Kevin Roadjack regarding first responders on the roof. The only evidence we have of any |
| | first responder attempting to climb the roof was the single officer at approximately 609 who attempted |
| | to get on the roof to view the subject who was already on the roof. |
| [00:19:20.600> 00:19:27.600] | We have no other evidence that indicates that any law enforcement officers were on the roof at any time. |
| [00:19:27.600> 00:19:38.600] | And regarding the second question, we need to get back to you on whether there were any prescription drugs in the system. |
| [00:19:38.600> 00:19:43.600] | The information that I have now just reports no alcohol or drugs of abuse. |
| [00:19:43.600> 00:19:56.600] | This is Kevin Roadjack again. I can confirm that there was no second shooter shooting at the former president. |
| [00:19:57.600> 00:20:07.600] | We know that there were 10 rounds fired that day, eight from our subject, one from a local law enforcement officer, |
| | and one from the secret service sniper. |
| [00:20:07.600> 00:20:22.600] | All the rounds have been accounted for and attributed to those three individuals. So we have zero reason to |
| | believe that there was ever a second shooter targeting the former president. Thank you. |

| [00:20:34.600> 00:20:43.600] | We have no forensic evidence indicating that that round either struck our subject or the subject rifle. |

| [00:20:51.600> 00:20:58.600] | From the initial night on June, July 13 continuing through today. |
| [00:20:58.600> 00:21:05.600] | They have provided all the information that we've asked and been extremely cooperative. Thank you. |

| | online search activity and we have a clear idea of mindset, but we are not ready to make any conclusive |
